[2] Material placed in a Recyclables Container other than Recyclables in quantities greater than 10%, as observed and documented by Company personnel, and (b) Material placed in an Organics Container other than Organics in quantities greater than 3%, as observed and documented by Company personnel, and (c) Excluded Waste in any quantity in any Container. Contamination charge applies to the third contamination incident after two warnings are issued.

[3] Defined as (i) Solid Waste, Recyclable Materials or Organic Waste exceeding its Container's intended capacity such that an individual lid is lifted by an average of at least 10 inches (or would be lifted by at least 10 inches if lowered) or (ii) Solid Waste, Recyclable Materials or Organic Waste placed on top the Container. Overage charge applies to the third overage incident after two warnings are issued.
